

# Privacy Policy

In order to sell goods and operate our website, we process certain personal data.

The processing of personal data is governed, without limitation, by Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (“GDPR”)

## I. Personal Data Processing

### A. Processing of personal data when using the contact form

If you enquire about our products and services, we will work with the contact details you provide, mainly via the enquiry form. These contact details are: Name and surname, date of birth, email, phone number

#### For what reason?

We will use your contact details for further communication about goods and products.

#### What is the legal basis?

The processing is based on Article 6(1)(b) GDPR – agreement negotiation or to take steps at your request prior to entering into an agreement.

#### How long will we process personal data?

If we do not establish further cooperation, we will process your data for a maximum of 1 year from our last communication.

### B. Processing of personal data in case of purchase

If you make a purchase with us, we will work with the data you fill in. These are mainly billing details: name, surname, address, phone, email

#### For what reason?

We need to process personal data to fulfil our agreement – to deliver our goods to you. We will also communicate with you via your contact details about the status of your order, or about complaints or queries you may have.

We will also process personal data for the fulfilment of our statutory duties (mainly for accounting and tax purposes, or to handle complaints, etc.).

What is the legal basis for data processing in this case?

The processing is based on Article 6(1)(b) GDPR – performance of an agreement and Article 6(1)(c) GDPR – performance of our legal obligation.

How long will we process personal data?

For the period of performance of our service and thereafter for 1 year from the last time we provide such service or supply the goods.

**C. Newsletters (commercial messages)**

If you are a purchasing customer and you have not rejected newsletters during purchase, we will use your email address to send our newsletter.

What is the legal basis?

Section 7(3) of Act No. 480/2004 Coll., on certain information society services, unless you have prohibited us from doing so at the time of purchase.

How long will we process personal data?

1 year since your last purchase. You can unsubscribe at any time via email or contact us at: **info@aerowalla.com**

## II. How can you access your data?

Your data stays with us. However, we work with certain companies or other persons who get access to the data because they help us run our online store. These are:

- the operator of the Shoptet online store platform (Shoptet a.s., with its registered office at Dvořeckého 628/8, Břevnov, 169 00, Prague 6, ID 289 35 675, registered at the Metropolitan Court in Prague, section B, insert 25 395)
- sales department
- accountant

We process personal data only within the European Union.

## IV. Cookies

Cookies are text files containing small amounts of information that are downloaded to your device when you visit our website. Cookies are then sent back to the website or another website that recognizes them on each subsequent visit.

Cookies perform a variety of tasks, such as allowing you to navigate between websites efficiently, remembering your preferences and generally improving the user experience. They can also ensure that the ads you see online are better tailored to you and your interests.

We use the following cookies on the website:

- **Essential cookies:** are required to operate the website, for example, they enable you to log into secure areas of the site and provide other basic functionality of the site. This category of cookies cannot be disabled.
- **Analytical/statistical cookies:** they allow us, among other things, to identify and track the number of visitors and how our visitors use the website. They help us to improve the way the site works, for example by making it easy for users to find what they are looking for. We only run these files with your prior consent.
- **Advertising cookies:** are used to track preferences and allow you to see advertising and other content that best matches your interests and online behavior. We only run these files with your prior consent.

Please note that third parties (including, for example, external service providers) may also use cookies and/or access data collected by cookies on the website.

## V. Your rights in relation to personal data processing
